AGREED TERMS

- 1. Venue Control:** Phoenix Pride controls Steele Indian School Park from October 17-19, 2025. This is a revocable license to occupy; Phoenix Pride may terminate it at its discretion.
- 2. Mission Adherence:** Exhibitors must support Phoenix Pride's mission to unite, educate, and empower the LGBTQ+ community.
- 3. Photographic Rights:** Phoenix Pride reserves all rights to event footage; unauthorized use is prohibited.
- 4. Branding Restrictions:** Use of "Phoenix Pride" or event-related branding is restricted, excluding proper social media tagging.
- 5. Independent Contracting:** Exhibitors operate as independent contractors, not as Phoenix Pride employees or partners.
- 6. Application Submission:** Full payment validates the application. Must receive payment by October 1st.
- 7. Exclusivity:** Exclusive arrangements require separate agreements.
- 8. Exhibitor Check-In/Set-Up:** Food vendors must check in and set up on Friday between 8 am and 6 pm. No exceptions.
- 9. Vehicle Restrictions:** Only designated vehicles allowed during festival hours; must exit by 9 am.
- 10. Tent & Space Usage:** Use provided tent and space; unauthorized distribution is prohibited. Vendors must use flame-retardant tarps ONLY. Vendors are allowed to use Mesh Panels.
- 11. Noise Restrictions:** No loud or amplified sounds allowed.
- 12. Nudity Policy:** Limit public displays of nudity.
- 13. Alcohol Sales:** Prohibited; Phoenix Pride controls beverage sales.

14. **Drone Use:** Drone usage is prohibited.
15. **Ice Purchase:** 40lb ice bags available for \$20 at festival bars.
16. **Water Policy:** You must bring your own water for cooking and hand washing. Maricopa County Health Department requires that you provide appropriate cleaning materials as well as a hand-washing setup. LP- gas containers limited total aggregate WATER CAPACITY of 25 gallons (approx. 100 lbs.) per booth and shall be secured against toppling. They shall not be located within 10 ft. of tent walls or exits. Hoses shall be designed for working pressure of 350 psig AND be marked with LP-GAS, PROPANE, 350 PSI WORKING PRESSURE, with manufacturer's name/trademark. Hose length shall be 36 inches or less and hoses shall be maintained in good condition. Additional containers above permitted quantity shall be stored in a remote location approved by the AHJ.
17. **Trash Management:** Provide your own trash receptacle; remove trash daily.
18. **Oil/Grease Disposal:** Use provided recycling containers; violations may result in removal without refund.
19. **Soda/Water Sales:** Vendors must price beverages at a minimum of \$4 and have them option to through our partner, Swire/Coca-Cola. A Swire representative will contact food vendors for beverage orders closer to the event. Note: This excludes coffee, tea, lemonade, and other specialty drinks.
20. **Fire Safety:** Provide fire extinguishers and fireproof containers for discarding ashes. Fire extinguisher rate 2a-20B:C. In addition, vendors using deep fryers must also supply a rated Class K extinguisher. Vendors must use flame-retardant tarps ONLY.
21. **Water & Gas Safety:** Bring your own water and comply with gas container regulations.
22. **Food Storage:** Store food items as mandated by health regulations.
23. **Special Event License:** Obtain a Special Event Food Server License from Maricopa County Health Department. Call 602-506-6978 for application.
24. **Inspections:** Pass Fire and Health Department Inspections on Saturday morning at 10:00 am.
25. **Insurance Requirement:** Provide a Certificate of Insurance by OCTOBER 1, 2025.

26. **Indemnification:** Hold Phoenix Pride harmless from claims or liabilities.

27. **Workers Compensation:** Provide your own coverage for staff.

28. **Security:** The park will be fenced and closed to the public. Phoenix Pride provides 24-hour security. Exhibitors are not required to tear down Saturday night and can leave their items, however Phoenix Pride is not liable for exhibitor property left on festival grounds.

29. **Financial Expectations:** No guaranteed sales or profits.

30. **Refund Policy:** Non-refundable entries; exceptions apply before September 1st.

31. **Final Agreement:** This agreement supersedes prior negotiations.

ACKNOWLEDGEMENT

Any exhibitor, including their employees and/or volunteers who fail to comply with any provisions outlined herein shall be subject to exclusion from future Phoenix Pride Events. Any violation of rules and regulations outlined herein will be grounds for revoking this License to Occupy and forfeit all fees paid to Phoenix Pride.

Applicants warrant and confirm the information provided in their application is, to the best of their knowledge, true and correct, and further certify they have read all information provided and agree to comply with Phoenix Pride's Terms and Conditions.
